I agree to provide and wear a Consumer Product Safety Commission (CPSI) certified bicycle helmet at all times while commuting via bike as a participant in the Green Bike Project.

I agree to ride legally while commuting via bike in the Green Bike Project, abiding by all laws, regulations and rules of the road applying to bicyclists in King County and Washington State, including the requirement to wear a bicycle helmet.

I acknowledge that the Green Bike I receive will remain the property of Cascade Bicycle Club until I have fulfilled my bike commute pledge.

During the length of the Green Bike Project, I agree to keep the Green Bike in good working condition and accept responsibility for incidental upkeep.

I agree to store and lock the Green Bike securely, and acknowledge that Cascade Bicycle Club will not replace the Green Bike if stolen.

I agree not to modify the Green Bike structurally or in appearance while it remains the property of Cascade Bicycle Club. If the Green Bike shows evidence of abuse or misuse, Cascade Bicycle Club reserves the right to end my participation in the Green Bike Project and I will then promptly return the Green Bike to my employer.

I agree to complete an initial commute survey and then to log all of my commute trips on the Green Bike Project website - [www.greenbikes.net](http://www.greenbikes.net).

I agree that my log will be a truthful and accurate account of my commute behavior. The data in my log will be used for two purposes:

1. To calculate the total drive alone miles and trips eliminated by the Green Bike Project; and
2. To determine whether I have fulfilled my pledge for the Green Bike Project.

I understand that my employer will be involved in coordinating the Green Bike Project and has agreed to provide secure bike parking at work.

I agree to be photographed or interviewed for the Green Bike Project, and further agree to sign an appearance and/or testimonial release giving Cascade Bicycle Club permission to use my likeness and my statements.

If I cannot for any reason fulfill my pledge for the Green Bike Project, or if I leave my employer prior to the end of the term of the Green Bike Project, I understand that I must return the Green Bike to my employer who will return it to the Green Bike Project.

If I do fulfill my pledge for the Green Bike Project according to the rules of the Project and the worksheet below, my assigned Green Bike will become my sole property on or about July 31, 2010
